Service Descriptions:

Basic Editing: All photos will be corrected for any minor problems with light, color, etc.

Deluxe Editing: Special care will be given to each photograph to ensure best results. Detailed corrections will be given as required such as but not limited to: shadow/highlight correction, removal of skin blemishes, multiple framing options, specially treated B&W versions of select photos, combination of photos to ensure everyone in group is smiling, etc.

Art/Collage photo design: Custom designed art pieces created from one or more of your best photos

Online proofing with editing requests: All pictures available online for you and family to see. If you see certain photos with special editing needs you may request specific edits (i.e. remove a hair, pimple, etc.)

Separate day reception coverage: If your reception is held on a day other than your wedding day but you would like to use coverage time from your wedding day, the coverage will only be \$25. However, if the reception coverage time is in addition to your wedding day time the charge will be \$100 for 1-3 hours of coverage.

Single sheet invitation design: Invitations designed from your photos suitable to be printed as a photograph with pictures and wedding information on a single sheet

Contractual Agreement:

Terms and Conditions of this Contract:

1. ENTIRE AGREEMENT: This agreement contains the entire understanding between **Light Brush Studios Inc.** and **The Client** (party listed above under Client Information). It supersedes all prior and simultaneous agreements between the parties in both verbal and written communication. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties wish to waive or alter one provision of this agreement, that does not mean that any other provision is also waived.
2. CONSULTATION: **The Client** will be responsible for (or appoint someone responsible for) ensuring that any specific instructions for photographs are properly communicated. **Light Brush Studios Inc.** will NOT be responsible for failure to photograph specific people/objects of whom/which specific photographs are desired should **The Client** fail in their responsibility to identify said people/objects or assist in gathering people for photographs.
3. DIGITAL COPYRIGHTS, ARTISTIC PROPERTY: The digital negatives, photographs or prints produced by **Light Brush Studios Inc.** are protected by copyright law (all rights reserved). Final payment for services rendered determines the release of the disc and photographs of **The Client**. No photography may be reproduced in any manner without the explicitly written permission **Light Brush Studios Inc.** which is authorized by final payment. Upon final payment by **The Client**:
 - The digital CD/DVD or prints then become the property of **The Client** for their personal use and for the purpose of reproduction of said imagery for dispersal to relatives and friends. Images may be used on personal web sites. An acknowledgement to the Photographer is appreciated. **The Client** must obtain written permission prior to publishing or selling the digital negatives, photographs, or prints for a profit.
4. EXHIBITION: **The Client** allows **Light Brush Studios Inc.** to exhibit selected images resulting from this assignment as an example of previous work, for entrance into photographic competitions and to use as sample for other photographic opportunities.
5. MODEL RELEASE: **The Client** grants to **Light Brush Studios Inc.** and it's legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the parties or in which the parties or their family may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same.
6. LIMIT OF LIABILITY: **Light Brush Studios Inc.** will do all within reason to ensure the successful delivery of quality digital negatives. However, in the unlikely event of **The Client's** photographs being lost, stolen, or damaged for reasons within or beyond **Light Brush Studios Inc.** control, the latter's liability is limited to the return of all payments received for the event. The limit of liability shall not exceed the contract price stated in this contract.
7. PAYMENT: **The Client** will provide a 20% deposit of agreed fees upon signing of the contract. The remaining amount is to be paid upon delivery of final disc of digital negatives.
